Always rain or shine, the crab feast comes together thanks to *Jeremy Irons*, **The Belt Group** and our sponsors: **The Belt Group**, **First United Bank & Trust**, **Pinnacle Strategies, LLC**, **Western Maryland Building & Construction Trades Council**, and **WVU Medicine – Garrett Regional Medical Center & Potomac Valley Hospital**. Thank you to *Peg McKenzie* for her leadership with this event, which she has managed for over 30 years. If you're attending, look for our Board of Directors who serve as our Crabby Parking Crew throughout the evening.

It has been a busy month, even with some much-needed vacation time, as our **Transportation Committee**, led by *Courtney Thomas-Winterberg*, **Department of Social Services**, made strides in our efforts to form a robust transportation system in Allegany County. First, we presented our rideshare proposal to Uber, which included data from our community-wide survey conducted late last summer. There is some work to do to recruit drivers, but they acknowledge we have a market for the service. Our focus related to this will be to market to potential drivers and to find ways to incentivize those who qualify and reach milestones. If you or someone you know wishes to sign up, it's as easy as downloading the app and completing the steps. It is with an increased number of available rides that pricing and timing will make the service a viable option in our community. Second, the **Allegany County Board of County Commissioners** released a request for proposal on July 13, which is seeking a firm to conduct a transportation study and provide a strategic plan to outline specific actions to form a robust transportation system in Allegany County. The Chamber

is proud to partner with the **Allegany County Department of Economic and Community Development** and **Department of Social Services** to utilize Appalachian Regional Commission funds for this important step in the process.

**Turnbull, Hoover & Kahl, P.A.**

hosted a great *After Hours* in July and our Network & Win goes up to \$1,750 with no one present from Allegany Aggregates. We will be at **Town Hill Bed & Breakfast** in August – don't forget to pre-register online from our Chamber calendar.

We have continued to stay engaged in advocacy work thanks to our membership with the Maryland Chamber and the Federation. This has been a tremendous resource for information. The focus has been unemployment insurance, FMLI leave, and cannabis guidance and regulations, as well as some predictions of the 2024 session. If you are searching for information on any of these topics, you can find highlights in past E-News publications and you can always contact our office. I continue to have requests to hear from small businesses in Allegany County on these issues. ***Please take advantage of this often-overlooked membership benefit and feel free to communicate challenges to us so that we can make our voice heard in Annapolis.***

Our **Education Committee** will be coming together this month after our short hiatus. We will hear updates from all of our education partners and discuss 2023-2024 programming. It's been a great summer, but back to school will be here quickly! The Chamber will continue to administer the **Leadership Allegany Rising** program and there are \$250 and \$500 sponsorship opportunities available if your business wishes to support this high school junior experience.

## **FOOD SERVICE ONLY**

### **WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FOR EVENTS and FOODS OTHERWISE TRANSPORTED, FURTHER PREPARED AND CONSUMED**

Food preparation carries with it inherent risks that include but are not limited to health hazards resulting from improper transport, handling and storage.

#### **WAIVER**

In consideration of being permitted to prepare, bring in, serve or otherwise present any food samples or related service product or event at the Frostburg State University – Lane Center (the “Event”) where prepared food, cooked, perishable or otherwise are transported, further prepared, and consumed, we, our personal representatives or assigns, agents, employees and affiliates, do hereby release, waive, discharge, and covenant not to sue Allegany County Chamber of Commerce (the “Host”), their affiliates, direct or indirect, officers, employees, and agents from liability from any and all claims resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, any claim directly or indirectly to the Event.

#### **INDEMNIFICATION AND HOLD HARMLESS**

Vendor agrees to indemnify and hold harmless the Host, their affiliates, direct or indirect, officers, employees, and agents (the “Indemnitees”) from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including reasonable attorney’s fees brought as a result of my involvement in Events, whether brought by me, my company or its agents or employees, or other third parties, and to reimburse the Indemnitees for any such expenses incurred.

#### **A FEW SIMPLE PRECAUTIONS TO REDUCE THE RISK OF FOODBORNE DISEASES**

Safe and careful handling of raw meat and poultry is critical to prevent harmful bacteria from multiplying and contaminating other foods. It is extremely important that proper temperatures are reached during cooking to destroy harmful bacteria.

**COOK:** meat, poultry and eggs thoroughly. Using a thermometer, ground beef should be cooked to an internal temperature of 160°F. Eggs should be cooked until the yolk is firm. \*Keep burgers and chicken (and all other perishable foods) on ice until ready to cook. Cook poultry to 165°F/74°C.

**SEPARATE:** Don't cross-contaminate one food with another.

Pregnant women, the elderly, and those weakened immune systems are at higher risk for severe infections such as Listeria and should be particularly careful not to consume undercooked animal products.

Town Center Development Group's mission is to serve as a catalyst for the redevelopment of Downtown Cumberland. It engages in development, leasing and property management. Holdings include approximately 100,000 square feet in office, retail, arts entertainment and residential space. The company also operates retail businesses as well as an in-house architectural firm.

Town Center Development Group, LLC was formed in the summer of 2000 by principals Steve Chaney and Larry Jackson as a commercial real estate development company. Several goals were established at the time, including the mission to "provide economic development in Downtown Cumberland" and to "restore historic properties in the central business district."

The first project was the purchase of 115 Baltimore Street in June 2000. Shortly after purchasing the building was renovated on the exterior and on the 1<sup>st</sup> and 2<sup>nd</sup> floors. The company received the historic preservation award for the year 2000 from the City of Cumberland. In the spring of 2001, the building next door, 113 Baltimore Street was purchased. In the summer of 2001 an ambitious project of complete renovation on the third floors of both buildings, as well as the first and second floors of 113 Baltimore Street was undertaken. The concept was formulated to create one unified building of 18,000 square feet. This project was completed in the spring of 2002. The project, known as the Town Center Building, was a winner of the State of Maryland "Smart Growth Award" for 2002.

In the spring of 2003, Decatur Heights Development, LLC was formed to develop the Decatur Heights section of Downtown Cumberland. Two large historic commercial buildings were acquired (The Deal Building and Allegany Towers) to serve as the center piece of the office campus master plan. Today the finished campus contains over 60,000 square feet of office space. Other projects include the development of 86 Baltimore Street, which was awarded the historic preservation award for the year 2003 from the City of Cumberland, and the Elks Building, 121 Baltimore Street, 127 Baltimore Street and the latest project 107 Baltimore Street.
